

MOTHER ADVISOR & ADVISORY BOARD INSTRUCTIONS FOR A GRAND OFFICER RECOMMENDATION

Eligible Advisory Board Members will receive evaluation forms as ballots.

If there is any discussion about an eligible girl, we respectfully request parent(s) or relative(s) to leave the meeting area. Nominations are CONFIDENTIAL and are not to be discussed outside an Advisory Board Meeting!

The ballot form is graded from a low score of one to the highest score of 5.

Consideration should be focused on maturity, responsibility and reliability. A Grand Officer should be a LEADER, SERVICE ORIENTED and DEDICATED. She should possess poise and social skills. She must be willing to participate and follow directions.

Mother Advisors: Please complete 2 forms. An Advisory Board Member form and the Mother Advisor form.

REQUIREMENT: A girl who has served as W.A. of the I.O.R.G. is eligible for consideration if she has fulfilled the requirements of that office with the approval of the advisory board.

AGE: A girl must be 16 years of age and /or entering her JUNIOR year in High School in September. Grand Officers must be INSTALLED on or BEFORE their TWENTIETH birthday.

GRAND CROSS: This designation is not required however, a girl that is being considered as a Grand Officer should have met all the requirements for Grand Cross Designation. It is a reflection of the SERVICE she has performed for her Assembly, District and RAINBOW.

PROFICIENCY: Ritualistic work is important and must be considered!

ATTITUDE: She must be willing to take direction and instruction from local and jurisdiction advisors. **She must be willing to continue working as an active member in her assembly and district unless she is in college.**

IMAGE: A girl must adhere to the RAINBOW DRESS CODE and all expectations for her conduct while representing Rainbow as a Grand Officer.

When your forms are complete, **fold them in half** and place them in the pre-addressed "Return" envelope and mail to the Supreme Inspector by May 15th.
