# **GRAND OFFICER APPLICANT INSTRUCTIONS**

## **(TO BE SUBMITTED WITH ATTACHED CONSENT FORM)**

Guidelines to follow for Rainbow girls interested for consideration of an appointment as a Grand Officer in Washington Idaho Grand Assembly.

1. Complete attached form.
2. Age Requirement: 16 years of age by Grand Assembly.
3. Enclose a 3x5 or 4x6 (glossy) picture of self. The pose may be casual or formal in nature however, GROUP pictures are not acceptable.
4. The Form and Letter must be scanned, typed or written in ink!  
**IT MUST BE LEGIBLE!**
5. Write a CONFIDENTIAL **ONE** page letter to the Supreme Inspector. **Additional pages will not be read!** Share your perception of the I.O.R.G. as a club that is in your respective community. Explain the reason you would like to be appointed. Why are you worthy of an appointment? Sign, date and seal the envelope, then place your signature over the sealed flap.
6. The attached Consent Form, letter and picture must be returned on time to your Grand Deputy.

NOTE: It is acceptable to request a specific office BUT if you talk about your choices with anyone, it won't happen. If you don't like the office you receive at Grand Assembly, you are welcome to resign it the night of appointments.
